## APPENDIX 1

Proposed changes to the Club constitution:

- 1. Members who are exempt from payment, which may include Honorary Members, are automatically Fully Paid-Up Members
- 2. Vice President Members are Members of the Club so elected by the General Committee either for life or for a specified period
- 3. Youth Development Manager shall be known as "Junior Cricket Manager"
- 4. Chairperson of the Cricket sub-committee shall be known as "Club Captain"
- 5. The quorum at any meeting convened under Article 6 of the Constitution shall be ten Fully Paid-Up Members over the age of 16 or Playing Members over the age of 16, as appropriate.
- 6. Various clarifications and correction of typos in draft Constitution (see track changes within document "Proposed HHTCC Constitution 2018")
